



# 2023 Forum on Central Bank Cross-Border Foreign Currency Operations

November 6 - 8, 2023 Beach Rotana Hotel Abu Dhabi, United Arab Emirates

#### 1. EVENT DESCRIPTION

The Arab Monetary Fund (AMF) and the Official Sector Service Providers (OSSP) Roundtable will organize a three-day high-level discussion and partner meeting forum that covers topics relevant for AMF members in the operation of their foreign currency accounts with OSSPs. This operations-focused in-person event will be a unique opportunity for official institutions in the region to meet directly with their official sector account service providers in one location. Participants will also have the opportunity to learn about the global landscape for reserve currency account services and to participate in discussion of common challenges in managing risk associated with official cross-border payment operations in an evolving risk environment.

## 2. EVENT PROGRAM

A preliminary agenda for the forum is enclosed. Sessions will be led by representatives from the AMF and OSSP member account service departments, covering such topics as:

- Cross-border payment operations and associated risk management activities by central banks.
- Managing the impact of "de-risking" by financial institutions, as well as expectations for compliance with national/international sanctions and Anti-Money Laundering/Countering the Finance of Terrorism laws, international best practices, and OSSP policies as they relate to central banks' own account activities.
- Evolution of the threat landscape for official payments (e.g., SWIFT cyber threats) and international efforts to strengthen the security of the cross-border payment chain.
- Central bank account incident response and contingency expectations.
- Payment message formatting guidance and issues related to the implementation of the ISO 20022 messaging standard.
- Select AMF and OSSP services, asset markets, and operational requirements for participation.
